Duties and responsibilities:

- Assess whether the IT activity at KPST is conducted in accordance with the policies and procedures of the institution.
- Assess whether the current IT policies and procedures are in accordance with the relevant regulations of the Central Bank of Kosova, and appropriate for the Institution's activity.
- Assess the risks to which KPST information systems and records are exposed.
- Evaluate the continuity and sustainability of IT in case of infrastructural complications or major disasters.
- Assess the division of responsibilities, staff adequacy, expertise and training needs within the IT sector.
- Examine the rights of the users, as well as the existing internal controls that relate to their actions in the main administrative applications of the KPST.
- Plan the IT audit processes, based on the identified risks, and send the Plan (in Albanian and English) to the Board for approval.
- Prepare the work papers for the documentation of the tests performed regarding the IT Audit and send them to the Internal Audit Department.
- Prepare the report (in Albanian and English) on the findings identified and recommendations for improvement according to the standards and best practices and reports to the Internal Audit department and the Audit Committee/Board.
- Perform other tasks that may be assigned to it by the Board of Directors and the Internal Audit Department in relation to IT Audit.

• Be a graduate - at least at the bachelor level.

CISA or CRISC certification issued by ISACA.

certification:

• Have knowledge of written and spoken English.

Experience:

• At least 2 years of professional experience in IT auditing.
